Minor Convictions

After the dmv.txt file information has been transmitted to the court's assigned address and the driving record is updated, we will return the completed and exception reports to the court's assigned space. There will be up to 4 files returned as text files.

ADDS.TXT

We will return the conviction information in the same format as it was received. All the convictions were added to the driving record.

ERRS.TXT

We return the conviction information in the same format as it was received. We then create a new record with a description of the error(s). A record may have more than one error. If there is more than one error, they will be listed individually, one after another. Each error text will start with: * * *. If two or more convictions were sent on the same record and one has an error, then NONE of the convictions will be added to the driving record.

999s.TXT

These are records that had a 999 conviction code (which indicates non-moving violations). None of the 999 conviction codes are added to the driving record. We will return the information in the same format as it was received. This process will indicate you have submitted non-moving violations to us (in lieu of the paper process), therefore, complying with Kansas law.

DUPS.TXT

These are records that were sent in previously and already updated on the system. They have not been updated a second time. Records should only be sent in once for update. This file will hopefully be empty but, it's a way to let you know about these records.

Suspensions/Reinstatements

After the dmv.txt file information has been transmitted to the court's assigned address and the driving record is updated, we will return the completed and exception reports to the court's assigned space. There will be 3 files returned as text files.

ADDS.TXT

We will return the suspension/reinstatement information in the same format as it was received. All the charges were added to the driving record.

ERRS.TXT

We return the suspension/reinstatement information in the same format as it was received. We then create a new record with a description of the error(s). A record may have more than one error. If there is more than one error, they will be listed individually, one after another. Each error text will start with: * * *. If two or more charges were sent on the same record and one has an error, then NONE of the charges will be added to the driving record.

DUPS.TXT

These are records that were sent in previously and already updated on the system. They have not been updated a second time. Records should only be sent in once for update. This file will hopefully be empty but, it's a way to let you know about these records.

Major Convictions

After the dmv.txt file information has been transmitted to the court's assigned address, we will return the completed and exception reports to the court's assigned space. There will be up to 2 files returned as text files. These convictions are not automatically updated to the record at this time. They will be manually updated.

ADDS.TXT

We will return the conviction information in the same format as it was received. All the convictions passed edits and are ready to be updated to the driving record.

ERRS.TXT

We return the conviction information in the same format as it was received. We then create a new record with a description of the error(s). A record may have more than one error. If there is more than one error, they will be listed individually, one after another. Each error text will start with: * * *. If two or more convictions were sent on the same record and one has an error, then NONE of the convictions will be added to the driving record.
