Web Services Instructions

Contains the file layouts and codes for minor convictions, major convictions, and suspensions/reinstatements for failure to comply that are used with electronic submission. These layouts provide specific information regarding what data should appear in each field and how it should be formatted. This Compiled Doc also contains test records required for testing the application with the State as well as examples of the return files and possible errors you will receive after submitting information to the State.

You can find instructions to set up the Court Transmission Client & the Court Transmission Client Application on our court's website at https://www.ksrevenue.gov/courts/downloads.html.

If you **ARE NOT USING** court software to generate submission txt files, you may also obtain the CSV file instructions and spreadsheets that will be needed for electronic submission at <u>https://www.ksrevenue.gov/courts/downloads.html</u>.

If you **ARE USING** court software to generate submission txt files, you will need to contact your vendor for assistance in making sure everything is set up properly to connect with the Court Transmission Client Application.

Please note: If you are currently set up in "Test" you will need to contact Asia Puck and specifically request to be put into "Production" once you are ready to send data to live records, otherwise you will remain in "Test" and no data you submit will hit any live records.

Return Files

After the dmv.txt file information has been transmitted to the court's assigned address and the driving record is updated, we will return the completed and exception reports to the court's assigned space separately for each submission type.

For Minor Convictions: There will be up to 4 files returned as text files.

For Major Convictions & Suspensions/Reinstatements: There will be 3 files returned as text files.

Below is an explanation of the returned text files you will receive:

ADDS.TXT - ALL SUBMISSION TYPES

We will return the conviction and suspension/reinstatement information in the same format as it was received.

- If a KS Driver's license was provided, the convictions/suspensions were added to the driving record automatically.
- If no KS Driver's license was provided but a KS address was provided, the convictions/suspensions will be added to the driving record manually.
- If an out of state jurisdiction, driver's license or address is provided, the convictions/suspensions/reinstatements will be sent out of state for processing.
 - o Driver Solutions will not retain any copies of suspension/reinstatement notices that are sent out of state.
 - If a record shows the driver has transferred their KS DL to another state, the conviction/suspension/reinstatement will be sent out of state.
- All reinstatements for KS drivers will be updated manually, all reinstatements for out of state drivers will be sent to the driver's home state for processing.

ERRS.TXT - ALL SUBMISSION TYPES

We return the conviction and suspension/reinstatement information in the same format as it was received. We then create a new record with a description of the error(s). A record may have more than one error. If there is more than one error, they will be listed individually, one after another. Each error text will start with: ***. If two or more convictions were sent on the same record and one has an error, then NONE of the convictions will be added to the driving record.

DUPS.TXT – ALL SUBMISSION TYPES

These are records that were sent in previously and already updated on the system. They have not been updated a second time. Records should only be sent in once for update. This file will hopefully be empty but, it's a way to let you know about these records.

999s.TXT - MINOR SUBMISSIONS ONLY

These are records that had a "999" conviction code (which indicates non-moving violations). None of the 999 conviction codes are added to the driving record. We will return the information in the same format as it was received. This process will indicate you have submitted non-moving violations to us (in lieu of the paper process), therefore, complying with Kansas law.
