Any antique vehicle being sold on a bill of sale that is 60-years old or newer will require an MVE-1,(Motor Vehicle Examination) issued by the Kansas Highway Patrol and submit when applying for antique title. Application for title must be made within 60 days of the purchase date in the county treasurer's motor vehicle office in the county in which the vehicle will be located / garaged. Penalty will be assessed on and after the 61<sup>st</sup> day.
