All sales of vehicles exempted pursuant to this paragraph, except truck, truck tractors, pole trailers, trailers and semitrailers as defined by K.S.A. 8-126, and amendments thereto, shall be registered in Kansas prior to the sale.

That these transport permits will only be issued for vehicles sold at auctions conducted within the state of Kansas, by my company. That I will only issued one such permit to the same person for the same vehicle.
