A LIEN RELEASE FROM THE CURRENT LIEN HOLDER MUST BE RECEIVED BY THE DIVISION OF VEHICLES WITHIN 30 DAYS OF THE DATE OF THIS APPLICATION. FAILURE TO PROVIDE THE LIEN RELEASE WITHIN THE REQUIRED TIME FRAME WILL RENDER THIS REFINANCE APPLICATION INCOMPLETE. IF THE APPLICATION IS RENDERED INCOMPLETE, THE APPLICANT WILL NOT BE ABLE TO RENEW THEIR REGISTRATION UNTIL THE ORIGINAL LIEN IS RELEASED.

- 10. If the current lien holder listed above fails to comply with the lien release requirements of KSA 8-1,157, the refinancing lien holder may file a complaint. If a complaint is not filed or a lien release is not received within 30 days, the application will be rendered incomplete, as certified above, and the registration cannot be renewed.
